# Board Assessment

## General Assessment and Board Initiatives

Our Board term has just started, and even though the beginning was a lot of work and full of challenges, we are happy with how it has turned out so far.

Over the summer break we had weekly meetings, utilizing Whatsapp Videocall to our advantage, in preparation for Introweek and beyond. They were useful, but communication was not optimal, since we were spread all over the globe and it was challenging to find times that worked for all of us, whilst being in a place where we all had proper connection. The week before Introweek we spent most of our time in EUC for preparation, similarly to Introweek itself.

Throughout Quad 1 we either had one or two meetings a week.. We are happy with how this has turned out, and are planning to keep this up throughout the year.

A big decision that we made before Quad 1 was to completely revamp the website. This decision was mainly based on the lack of professionalism and speed in the website, which we wanted to amend. The website also allows us to promote all our events in a more effective manner. It took a lot of time and effort, but we are incredibly happy with how it has turned out, and hope you are too.

Additionally, we decided to renew the concept of the sportpass - which is now available for all non-EUC students - and create Music pass for all non-EUC students, living in LUCIA.

Overall, Quad 1 has met and exceeded our expectations and we are happy with its turn out. As we can only assess the Quad from our perspective, we highly encourage giving us your feedback via the earlier mentioned feedback form.

## SAAC Collaboration

SAAC and EUCSA have maintained good communication throughout the Quad, through informal meetings. We have also been able to meet with SAAC's newly elected first year representative: Fee Kruse. Although we were not able to have a proper team building event with SAAC, we plan to do so later in Quad 2. As for event collaboration, Quad 1 saw the very first study groups of this academic year, which were successful, selling nearly 150 tickets.

Another part of our collaboration is MEDA, for which we have redistributed the communication system and workload.

## **EUC Relationship**

Biweekly meetings were arranged with EUC's student life officer, Roel ten Hengel. These meetings were extremely useful for facilitating communication between EUC and our association. However, we were not able to meet with Gera and Matthew yet. We will meet with the MT in Quad 2.

## **Assessment of Board Events**

### **Introweek**

We are quite pleased with this year's Introweek and have received great feedback from both first years and guides. We mainly stuck to the formula of last years' Introweek, because we were happy with how that turned out and we had our plate full with other projects like the website and restructuring the online worksphere.

Attendance at all events has exceeded expectations, especially at the *Crafts & Quesadilla's*. We were greatly pleased with the amount of volunteers for the crew and especially Floor Angels —thanks to everyone who helped! Although there were a couple elements that could have been improved, there were no major failures or crises. All these possible improvements have been noted for next year's Board, and we hope that the 2026 Introweek will continue this trend of building upon existing foundations in order to deliver a memorable introductory experience to incoming EUC students.

### **Social Drinks**

In the middle of Quad 1 we hosted the first Social Drinks of the year at Pardoën. A staple in the EUCSA community. Despite turnout concerns, the general turnout was great, with even some alumni swinging by. Overall, it was a great get together of old and new friends.

## **Quad 1 GA**

The first General Assembly of the year turned out satisfactory. Two changes were made in the Policy Manual and the Budget Allocation passed as well. There was also a motion raised about the revitalisation of both Bar Co. and Touching Grass Co.- both still exist, but now with more transparency and trust from the community.

Further, topics such as the collaboration with SAAC, AC, and the IC were discussed. For more information, please refer to the GA 1 Minutes. Overall, we are happy with the turnout and we are looking forward to the next GA in Quad 2.

## **Financial Overview**

### **Financial assessments & Updates**

This quad was rather involved on the financial end; memberships opening up, events rounding out the financial year 2024-2025, the new budget proposal and all the changes therein.

Secondly, the quad itself started with Introweek, only of the most financially intense events of the year, though the budget provided was adequate in allowing the week to run smoothly, and the (marginal) leftovers of which have been transferred over into the portion of the reserves which were released in the budget proposal.

The day before Introweek, membership sales were also opened, and ran until a handful of days before the budget proposal, so as to ensure sources of revenue for allocation were near-definitive. However, due to high demand, we reopened for a small period for all those who wanted to go on the Ski-Trip and the EUCSA Weekend

On the topic of the budget allocation; during the first GA on the 6th of October, following the budget open floor one week earlier, the budget plan passed with 85% approval, meaning that there is now a definitive roadmap for the upcoming year.

The Collaborative Pot is continuing this year, but has slightly been adjusted to better support collaborations between our committees.

The newly-approved budget plan comes into effect at the start of Quad 2, and will run to the end of Quad 1 next academic year.

Sadly, there are now some more fees on the side of our members when purchasing tickets. WIX, our Website holder, is now charging a 2.5% fee for every transaction run- this was implemented on September 25th.

Is anyone reading this? I really hope so. If so, we like to reward you. The first three people coming to the Boardroom and say to a boardmember: 'Tigers are awesome', will receive a gift.

Additionally, our tax status is changing, so we are now paying taxes on the income we make from ticket sales- this is reflected in the decreased membership and subsidy funds, with money being set aside for taxes. That being said, we are in the process of talking to the Dutch government about what exactly we are required to pay, as Dutch tax law for associations is very vague. # Committee Feedback

## Progress of Nina's Committees

### Accessibility Co

Accessibility Co is a fully established co (even though one member stepped down, they immediately managed to fill the position again). They proved their effectiveness, whilst considering the fluctuating capacities of their disabled members, when organising their first event – *the Sit-In* – during which snacks, presentations and discussions around accessibility at EUC were organised. Attendance varied throughout the day but overall, the event gained a lot of positive feedback – including staff feedback. Although the committee started promoting on time, their second event (*a venting circle*) had no attendance, but the Co. is considering what they can do to improve. Looking forward, they have many ideas ranging from long-term plans such as collaborating with SAAC on the contemplation room, to events such as a comeback of the successful *blindfolded-dinner*.

### Charity Co

Although Charity Co. started out as an empty committee, it is now a complete committee of six members, with two first years taking on the Chair and Treasurer positions. Their work has been highly motivated and organised resulting in their collaboration with POC and Sport Co. for the *charity run*. All the money they raised, as well as their leftover budget was donated to the IRC and its work on immediate survival support and stability in Sudan. They have many exciting ideas for the future varying from traditions such as the *Valentine Rose Sale* to *Giving Week*.

### Dance Co

Dance Co. has filled all its positions with members of all cohorts and various dance backgrounds. Internal organisation is strong, as they assign tasks and set long term goals related to UCSRN and trainings. In Quad 1, they hosted two *open*

*trainings*, allowing any student no matter their dance background to join. Both trainings – hip hop and commercial, which were given by its own members, had a high participation rate which sets the tone for future trainings and UCSRN excitement. In Quad 2 they plan to host more open trainings, already starting with a jazz training in week 1, as well as having an external choreographer and trainer come in for a training. In the background they have been working on UCSRN choreography and are currently working out the logistics for auditions in Quad 2.

### **Debate Co**

Being a fully established Co with many new members, Debate Co immediately started working on their plans for the year in a very structured way, which paid off during the *Drunk Debate* which was a huge success – attendance doubled to the previous year and feedback was very positive. Next to this they also created more promotion platforms tailored to all those students interested in Debating, including a separate WhatsApp group chat and a Debate Club presentation. Quad 2 will immediately start with a *Panel Discussion on Public Speaking* in collaboration with MEDA, a *Musical Debate* with Performance Co and the first Debate Club meeting featuring an EUC alumni guest speaker. In the long run they are working effortlessly to make an EUC NMUN simulation event happen and are reaching out to other UC's debating societies.

### **Gala Team**

Gala Co is a full committee, consisting of members across all cohorts. Their main focus in Quad 1 has been on filling all empty GM positions, which they have successfully achieved through good Introweek presence. Next to this they are scouting possible Gala venues, which they are currently finalising. In Quad 2 they are planning to figure out logistics such as the DJ, their theme etc.

## **MEDA**

MEDA managed to find representatives for each department across cohorts and started off strong with organising an *Info Session* in week 3 together with a law alumni, which was appreciated by students interested in law. Additionally, another *Alumni Info Session* was hosted for those interested in economics, studying in the UK and career advice. Another exciting change was the creation of a new position – the First-year general member, which allows first years to get involved in MEDA and is vital for its continuation in the long run. Internal organisation is strong despite being a bigger committee and a focus will be on improving promotion. Together with Debate Co., they have been working over the break to ensure that their *Public Speaking Event* on the very first day of Quad 2 runs smoothly and are looking forward to how this turns out. Long term goals include case-solving workshops, an *ICC Visit* and many more.

## **Merch Co**

After initial struggles to find a treasurer, Merch Co is now a fully established committee with six members. They plan to do the typical Merch drops including the infamous EUC Hoodie, whilst adding their own twists with new designs. One problem which was carried over from last year's accessory drop, was a missing thermos delivery. However, after some intense searching and inquiries, the lost thermoses have been found and can now be given out to those who purchased them. Since this includes graduates, the committee is currently figuring out the logistics of delivery, pickup etc.

## **Sport Co**

Sport Co. managed to fill almost all of its positions before the start of Quad 1, which facilitated the organisation of sport training from the start, all though their organisation was improved further throughout the Quad. After intronweek, the Social media position and Football captain position were filled as well which contributed to

the success of the collaborative *Charity Run* event, which received positive feedback. Trainings have been going well in all sports, especially girls football has seen an increase in participation compared to last year. However, rugby has been difficult to establish properly, so they will focus on improving the organisation of this new sport addition to their committee. They also aim to host and improve events in the next quad, especially in collaboration with other Cos.

### ***TEDx Team***

TEDx is yet again a big committee with, in total, ten members who work together towards the final *TEDx*. Despite having members across all cohorts, including some exchange-students, organisation has been going well, especially with the help of meeting notes and reminders. This year's theme is "Invisible forces, visible impact" and speakers are now able to apply and give a TED talk related to this theme. Next to working on the theme and speakers application, the team has been looking for potential sponsors and is figuring out logistics of the event itself.

### ***Grass Touching Co***

Grass Touching Co. represents the formerly "Health & Wellness Co." and was greeted with excitement from the EUCSA community with all of its positions being filled from across cohorts. Nonetheless, a minor setback occurred when a motion was filed against them, which questioned the legibility of Grass Touching Co's existence. Hence, their energy was put into preparing their defence and ensuring the survival of the committee, which paid off since the vote during the GA was in clear favour of the continuation of Grass Touching Co. Due to this and a lack of budget and venues, no events were organised in Quad 1. But they are set on changing this in quad 2, for which bouldering and possibly yoga is planned. Their long-term goal is to organise canoeing and surfing in the warmer months, but ideas for the winter include a new-years polar plunge.

## **Progress of Sophia's Committees**

### **Arts and Crafts Co**

Arts and Crafts Co. is a full committee with students from each cohort. The committee is ambitious and has realistic events and collabs planned for the year. They already hosted a *Paint and Swap* event which was successful and have many ideas already for Quad 2, including an event occurring in the first week of Quad 2.

### **Exhibition Team**

The Exhibition Team has met and started planning future events. The committee is mostly formed and has made the first steps towards planning their main event which is the *End of Year Exhibition*. Along with working towards their *Mid-Year- and End of Year Exhibitions*, they are also planning other smaller events in Quad 2 & 3.

### **Feminist Collective**

Fem Co. is fully formed and engaged this year. They aim to have a broader variety of events and focus more on intersectionality. In Quad 1 they had *Sexy Wine Talks* which went well and had decent turnout. The group dynamics are good and they have events and collabs planned in Quad 2, including with the community external to EUCSA.

### **Film and Photography Co**

Film and Photography Co. is a fully formed committee who have many exciting events planned for the year. They had "The Summer I Turned Pretty" *Finale Screening* in Quad 1 which was incredibly successful, albeit having slight communication issues. They already have events planned for Quad 2 including a *Photo Competition*.

### **People of Colour Collective**

PoC Co. is fully formed which is super exciting as it was empty during last year's sign ups. The committee is very ambitious and had two events in Quad 1. Both of which were successful. They have a lot planned throughout the year and will hopefully manage to execute all their ideas.

### **Performance Co**

Performance Co. is fully formed and has started the process of putting on their *End of Year Performance*. They announced the musical of choice (*Footloose*) and have held auditions and sign ups for the crew and created their cast. They also had a *Footloose Screening* which went well. Overall a busy quad but they are very on track with their plans and will hopefully continue to be so in Quad 2.

### **Queer Collective**

Queer Co. is unfortunately only consisting of one member and thus not very active in this Quad. They have received a budget and plan to use that to help collaborate with other committees to plan events.

### **Sustainability Co**

Sustainability Co. formed their committee and have met and planned events for the upcoming Quads. They had an event planned that unfortunately had to be postponed due to bad weather. But have started a new *Paper Recycling Initiative* collecting old posters which they will use in an upcoming Quad 2 event. They also have another event planned in Quad 2 and also want to try and meet with external bodies for sustainability initiatives.

### **Writing and Journalism Co**

Writing and Journalism Co. has fully formed and also taken ESAJ (EUC Student Academic Journal) under their wing. ESAJ will act as a separate entity but is now technically part of their committee. They also hosted an event in Quad 1 which was successful and had good turnout and they already have more events planned in Quad 2.

## Progress of Vera's Committees

### Cultural Cooking Co

Cultural Cooking Co. has been going well and organized their first event, the *Block Party*, in collaboration with N&A Board and PoC Co. While they admitted it was perhaps not a good idea to plan it on the Wednesday before exam week, the people who came did enjoy it, as there was food, craft activities, and music, and it offered a nice break from studying. For Quad 2, they have some ideas, such as a movie night with cooking in collaboration with Film & Photography Co.

### Games and Entertainment Co

Games and Entertainment Co. consists of highly motivated members, who are all full of ideas for events and their promotion. Their first event was the *Clash Royale Tournament*, which was successful with high attendance, an engaged audience, and positive feedback (including questions about whether the event would return). They also organized a *Beerball Tournament*. Sadly, this event had a lower attendance than they had hoped, as it was the week before exams and the advertising was last-minute. Still, around 20 people participated in the tournament and they were positive about the event. For Quad 2, Games and Entertainment Co's plans include a *Dress to Impress* and a *Brawl Stars Tournament*, a *Board Game night*, and a *Pub Quiz*, and they will try to make as many of these events happen by delegating and starting early.

### Music Co

Music Co. organized its well-known, recurring *Open Mic* in the Lucia Basement. Overall, the event was successful; the turnout was good, and the people who showed up had fun, which was reflected in their engagement with the many (spontaneous) performances.. Music Co. has exciting ideas for the year, such as a *Tiny Desk* in Quad 2, the *Boiler Room* in Quad 3, and a version of the *Terrace Fest* in Quad 4.

### N&A Board

After the committee applications, the N&A Board initially consisted of only two first-year members. However, the chair successfully convinced four other first-years to also join it, so now it is a full committee! In collaboration with Cultural Cooking Co. and PoC Co., they organized the *Block Party*, and they are now planning on raising awareness among other committees about how they can get more money and how the N&A Board can help them, for example, by applying for the trust fund of EUR. Additionally, they are figuring out how they can promote products and events and perhaps organize events of external organizations in exchange for discounts for EUCSA members.

### **Party Co**

Party Co. organized their first event, the *Rooftop Party*, at a beautiful venue. The tickets for the party sold out in just over a day because of their effective promotion, and the party received a lot of positive feedback: many guests had a great time, and the DJ was happy to play. For future parties, they are looking for venues that allow more guests so that a larger number of people can enjoy the party. With many committed members, Party Co. has exciting ideas planned for the rest of the year, such as collaborations with Bar Co., Ski Team, and Dance Co.

### **Podcast Co**

Podcast Co. has very enthusiastic members with many creative ideas. They started the year by changing the Podcast's name to "*Pre's at ours*" and are currently brainstorming ways to execute as many of their concepts as possible. Most of their ideas include collaborating with other committees, as they plan to interview people at EUCSA events. They also aim to talk with MEDA about career-oriented and academic topics. Ideas not specifically tied to other committees include creating content about Rotterdam must-sees, tips on how to survive the first year, and recording spontaneous morning or after-party talks in the trams.

### **Ski Team**



Ski Team started planning and organizing the upcoming *Ski Trip* throughout the summer. Despite some difficulties with the Totally Snow account, they successfully managed to book the Trip. This Quad, the team hosted two events: *Ski Team Social Drinks* and the *Ski Trip Info Session*. The *Info Session*, in particular, went very well. Currently, the Team is working on improving their marketing, including making their social media more organized. They are also working on the ticket sale for the *Ski Trip*, which will happen in Quad 2. The team is starting to bond, and it looks very promising. They have lovely ideas for collaborations with other committees, such as with Merch Co. and Party Co. before the *Ski Trip*, and plans for a podcast on the slopes, a race, and disposable cameras during the *Ski Trip* itself.

### **Travel Co**

Travel Co. can be a challenging committee, due to the variety of event possibilities, ranging from small day trips to larger excursions outside of the Netherlands. Travel Co. is thus focusing on determining both what EUSCA members want and what the committee can realistically organize and provide. Their current plans for the rest of the year include a *Trip to Explore Rotterdam*, an *Excursion to Utrecht*, and a potential longer trip in Quad 3 or 4 to a European city like London or Paris.

### **UCSRN Team**

EUSCA's UCSRN Team is complete and started this Quad by promoting the *Trisports Tournament* organized by Amsterdam University College. The team is now planning to organize a *Pub Crawl in The Hague* in Quad 2. This event will be a collaboration with other EUSCA committees and, hopefully, Leiden University College, which is based in The Hague. Additionally, they are brainstorming about a fun EUC audition process pre-*Spotlight* and other events open for different University Colleges, such as a *Christmas Market Trip*, *inter-UC Speed Dating*, or a *Beach Day*.

### **Yearbook Co**

Yearbook Co. is doing pretty well so far. Since they did not have much to do yet in Quad 1, they focused on planning for the year and deciding what *The Yearbook* should look like. While their main project is, of course, *The Yearbook*, they also want to plan more small projects to get more input from people outside the committee and to promote *The Yearbook* already throughout the year. Examples of this include creating a *Memory Wall* and putting together a Spotify music playlist that can be featured in *The Yearbook*.

## **Progress of Anna's Committee**

### **Bar Committee**

Bar Co. has formed their committee fully, with members from first, second, and third year. They did not have an event this Quad, and had a bit of a rocky start with establishing the committee, but they have several exciting events for Quad 2 planned!

## **Intersectional Council and Advisory Board**

The IC as well as the AC are intended to advise us as a board in daily and long term decisions. We are happy that both are fully formed and the first meeting with the AC already took place. The first meeting of the board and IC is happening in the first week of Quad 2 and we are confident to establish a supportive relationship with both councils.
